

EMGD | Simplify Emerging Markets Equity PLUS Downside Convexity ETF

FUND OVERVIEW

The Simplify Emerging Markets Equity PLUS Downside Convexity ETF (EMGD) seeks to provide capital appreciation with exposure to emerging equity markets while boosting performance during extreme selloffs in emerging markets via a systematic options overlay.

The fund's core holding provides investors with emerging markets index exposure. A modest option overlay budget is then deployed into a series of options positions that help create downside convexity in the fund.

PERFORMANCE REVIEW

Emerging markets had a mild first quarter when compared to some of its index peers like the Nasdaq 100 Index or even US Large Cap Equities. As expected, EMGD lagged its benchmark due to option premia decaying without monetization, but the underperformance was a bit less than the 0.9% of purchased premia, as the core equity exposure we hold (EEM) outperformed the MSCI Emerging Market index by about 0.2% on the quarter.

We are pleased with the fund's updated algorithm that was implemented last quarter, providing a means to run our entire convexity suite completely systematically while still offering the potential for significant added convexity.

The option premia spent during 1Q was 0.15% above the fund's 0.75% steady state expected quarterly burn rate due to the initialization of our new algorithm during the quarter that required an extra month of budget spend.

DEFINITIONS

Burn Rate: The speed at which an unprofitable company consumes its cash reserves.

Convexity: An investment strategy is convex if its payoff relative to its benchmark is curved upward. Convex investment strategies are expected to be highly correlated with the benchmark in typical market environments but diverge to the positive in extreme markets. There are no free lunches though, and convex strategies are expected to lag during quiet markets.

Expiry: The time until an option expires. In the context here expiry is used to describe the length of time from when an option position is initiated to when it will expire.

Market Price: The current price at which shares are bought and sold. Market returns are based upon the last trade price.

NAV: The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

Option: An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a pre-determined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

SEC 30-Day Yield: The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.
