

# SPUC | Simplify US Equity PLUS Upside Convexity ETF

## FUND OVERVIEW

The Simplify US Equity PLUS Upside Convexity ETF (SPUC) seeks to provide capital appreciation by offering US Large Cap exposure while aiming to boost performance during extreme market moves up via a systematic options overlay.

The fund's core holding gives investors a low-cost, index-based exposure to US large caps. A modest option overlay budget is then deployed into a series of options positions that help create upside convexity in the fund.

## PERFORMANCE REVIEW

The S&P 500 Index had a stellar first quarter, up 7.5%. SPUC lagged by ~0.5% as the fund's slightly higher beta (~1.1) due to call deltas helped offset about half of the 1% call premium spent without significant monetization.

We are pleased with the fund's updated algorithm that was implemented last quarter, providing a means to run our entire convexity suite completely systematically while still offering the potential for significant added convexity.

The option premia spent during 1Q was 0.25% above the fund's 0.75% steady state expected quarterly burn rate due to the initialization of our new algorithm during the quarter that required an extra month of budget spend.

### DEFINITIONS

**Beta:** Slope coefficient of a linear regression between the S&P 500 Index and the underlying asset

**Burn Rate:** The speed at which an unprofitable company consumes its cash reserves.

**Delta:** The theoretical estimate of how much an option's value may change given a \$1 move up or down in the underlying security.

**Expiry:** The time until an option expires. In the context here expiry is used to describe the length of time from when an option position is initiated to when it will expire.

**Market Price:** The current price at which shares are bought and sold. Market returns are based upon the last trade price.

**NAV:** The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

**Option:** An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a pre-determined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

**SEC 30-Day Yield:** The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.
