

# SPYC | Simplify US Equity PLUS Convexity ETF

## FUND OVERVIEW

The **Simplify US Equity PLUS Convexity ETF (SPYC)** seeks to provide capital appreciation by offering US Large Cap exposure while aiming to boost performance during extreme market moves up or down via a systematic options overlay.

The fund's core holding gives investors low-cost, index-based exposure to US large caps. A modest option overlay budget is then deployed into a series of options positions that help create convexity in the fund.

## PERFORMANCE REVIEW

The S&P 500 Index had a stellar second quarter, up 8.74%. SPYC was on par with its benchmark, resulting from a ~-0.14% contribution from the options, offsetting a ~-0.08% underperformance in our core equity exposure (at an average 99.4% exposure during the quarter), and -0.06% in accrued management fees.

Regarding the options attribution, we rolled the June Call Spread with ~0.2% realized gains, and our July and August Call Spreads show unrealized gains of ~0.45% as of end of 2Q. This profit from the calls however was offset by the puts decaying with no monetized gains in this period.

The option premia spent during 2Q was 0.125% above the fund's 0.75% steady state expected quarterly burn rate as we rolled into a new structure with an extra leg on the puts side.

### DEFINITIONS

**Basis Points:** A common unit of measure for interest rates and other percentages in finance. One basis point is equal to 1/100th of 1%, or 0.01%.

**Burn Rate:** The speed at which an unprofitable company consumes its cash reserves.

**Call Spread:** Buying a call on a strike, and selling another call on a higher strike of the same expiry.

**Convexity:** An investment strategy is convex if its payoff relative to its benchmark is curved upward. Convex investment strategies are expected to be highly correlated with the benchmark in typical market environments but diverge to the positive in extreme markets. There are no free lunches though, and convex strategies are expected to lag during quiet markets.

**Expiry:** The time until an option expires. In the context here expiry is used to describe the length of time from when an option position is initiated to when it will expire.

**Market Price:** The current price at which shares are bought and sold. Market returns are based upon the last trade price.

**NAV:** The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

**Option:** An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a pre-determined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

**SEC 30-Day Yield:** The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.
