

SVOL | Simplify Volatility Premium ETF

FUND OVERVIEW

The **Simplify Volatility Premium ETF (SVOL)** seeks to provide investment results, before fees and expenses, that correspond to approximately one-fifth to three-tenths (-0.2x to -0.3x) the inverse of the performance of the Cboe Volatility Index (VIX) short-term futures index while also seeking to mitigate extreme volatility. SVOL aims to provide an attractive income stream and source of diversification while seeking to avoid risks inherent in other income-producing asset classes.

The fund's short VIX position provides investors an optimized exposure for monetizing the premium in the VIX futures market. A modest option overlay budget is then deployed into VIX call options to help protect against adverse moves in VIX.

PERFORMANCE REVIEW

SVOL returned +1.85% this quarter, as compared to -3.27% from the S&P 500 Index, highlighting the potential benefits of equity income strategies in challenging equity markets. Short positions in VIX futures contributed positively despite VIX increasing from 13.6 to 17.5, as the VIX futures curve benefitted from steep rolldown in a severely upward sloping curve (contango). The cost of tail hedging with VIX call options continued to be relatively cheap, given low volatility of volatility, and was largely offset by the income generated by cash invested in fixed income strategies.

The level of VIX is quite low on a historical basis, however, the futures curve is very steep due to the demand for buying VIX being significantly higher than the supply. In this market condition, SVOL has taken short positions in the intermediate part of the curve (as opposed to the front end) to have the potential to deliver positive returns even in a moderately rising VIX environment. SVOL also continues to have the potential to deliver higher income than a typical covered call strategy given the lower premium collected by those strategies in a low VIX environment.

DEFINITIONS

Contango: A situation where the futures price of a commodity is higher than the spot price.

Market Price: The current price at which shares are bought and sold. Market returns are based upon the last trade price.

NAV: The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

Option: An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a pre-determined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

SEC 30-Day Yield: The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.

VIX Index: A real-time market index representing the market's expectations for volatility over the coming 30 days.
