PFIX | Simplify Interest Rate Hedge Equity ETF

FUND OVERVIEW

The Simplify Interest Rate Hedge ETF (PFIX) seeks to hedge interest rate movements arising from rising long-term interest rates and to benefit from market stress when fixed income volatility increases, while providing the potential for income. The fund holds a large position in over-the-counter (OTC) interest rate options intended to provide a direct and transparent convex exposure to large upward moves in interest rates and interest rate volatility.

Using OTC derivatives, usually only available to institutional investors, PFIX is designed to be functionally similar to owning a position in long-dated put options on 20-year US Treasury bonds. Since the option position is held for an extended period, the ETF provides a simple and transparent interest rate hedge.

PERFORMANCE REVIEW

PFIX total return for the quarter was -21.57%. The fund's primary drivers of value continue to be its swaption-based exposure to forward rates at the long end of the rates curve and the implied volatilities associated with options on those same rates. For the quarter, the forward rates that are the underlying for the swaptions were down between 0.64% and 0.66%, and at the money normal model implied volatilities that map to the fund's options positions were down more than 0.09%. These moves, in combination with cross products that capture the interaction between rate and vol sensitivity, dominated the fund's performance for the quarter contributing -22.82% to the fund's performance. The fund's other positions in Treasury Bills, Treasury Notes, swaps and cash, in aggregate combined with fees, contributed 1.25% for the quarter.

DEFINITIONS

Forward Rate: An interest rate applicable to a financial transaction that will take place in the future.

Market Price: The current price at which shares are bought and sold. Market returns are based upon the last trade price.

Moneyness: Describes the intrinsic value of an option's premium in the market. A contract is either "in the money", "out of the money", or "at the money". A call option is said to be "in the money" when the future contract price is above the strike price. A call option is "out of the money" when the future contract price is below the strike price.

NAV: The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

Option: An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a predetermined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

Swaption: A contract to purchase the right to enter into a swap contract during the specified period of time.

SEC 30-Day Yield: The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers. yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.
