

# NMB | Simplify National Muni Bond ETF

## FUND OVERVIEW

The **Simplify National Muni Bond ETF (NMB)** seeks income with capital appreciation as a secondary objective. The fund is an actively managed ETF that seeks to achieve its investment objective by investing primarily in investment-grade U.S. municipal bonds, with attractive tax-free yields.

NMB also employs an actively managed municipal bond strategy that pursues opportunistic investing in securities overlooked by passive mandates. In addition, the fund runs a diversified, multi-asset options writing strategy seeking to further enhance returns. Foundation Credit is the fund's Subadvisor for the municipal portfolio.

## PERFORMANCE REVIEW

NMB launched on September 9, 2024. For its brief history through the end of 3Q, NMB returned 0.95%, outperforming the Bloomberg U.S. Municipal Index by 0.54%. Performance was assisted by the decline in interest rates, with the 10-year Treasury rate moving lower from 4.40% to 3.78% over the quarter.

Going forward, NMB will seek to outperform the Bloomberg U.S. Municipal Index through a combination of actively seeking the best opportunities in the municipal market and a risk-managed options selling strategy.

### DEFINITIONS

**Futures:** Derivative financial contracts that obligate parties to buy or sell an asset at a predetermined future date and price. The buyer must purchase or the seller must sell the underlying asset at the set price, regardless of the current market price at the expiration date.

**Market Price:** The current price at which shares are bought and sold. Market returns are based upon the last trade price.

**NAV:** The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

**SEC 30-Day Yield:** The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.

**To-Be-Announced (TBA):** A term that describes the forward-settling of mortgage-backed securities (MBS) trades.
