

PFIX | Simplify Interest Rate Hedge ETF

FUND OVERVIEW

The **Simplify Interest Rate Hedge ETF (PFIX)** seeks to hedge interest rate movements arising from rising long-term interest rates and to benefit from market stress when fixed income volatility increases, while providing the potential for income. The fund holds a large position in over-the-counter (OTC) interest rate options intended to provide a direct and transparent convex exposure to large upward moves in interest rates and interest rate volatility.

Using OTC derivatives, usually only available to institutional investors, PFIX is designed to be functionally similar to owning a position in long-dated put options on 20-year US Treasury bonds. Since the option position is held for an extended period, the ETF provides a simple and transparent interest rate hedge.

PERFORMANCE REVIEW

PFIX's total return for the quarter was 27.90%, reflecting the increase in long duration U.S. Treasury yields by 0.66%. The primary drivers of return continue to be its swaption-based exposure to forward rates at the long end of the rates curve and the implied volatilities associated with options on those same rates. For the quarter, the forward rates that are the underlying for the swaptions were up roughly 0.60% and the spot rates were up roughly 0.70%.

These moves, in combination with cross products that capture the interaction between rate and vol sensitivity, dominated the performance for the quarter contributing 27.10% to the returns. PFIX's other positions in U.S. Treasury Bills, U.S. Treasury Notes, swaps, and cash contributed 0.79% for the quarter, net of fees.

DEFINITIONS

Duration: A measure of the sensitivity of the price of a bond or other debt instrument to a change in interest rates.

Forward Rate: An interest rate applicable to a financial transaction that will take place in the future.

ICE U.S. Treasury 20+ Year Bond Index: Tracks the performance of US dollar denominated sovereign debt publicly issued by the US government in its domestic market. Qualifying securities must have greater than or equal to twenty years remaining term to final maturity as of the rebalancing date, a fixed coupon schedule and an adjusted amount outstanding of at least \$300 million.

Market Price: The current price at which shares are bought and sold. Market returns are based upon the last trade price.

NAV: The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

Option: An option is a contract that gives the buyer the right to either buy (in the case of a call option) or sell (in the case of a put option) an underlying asset at a pre-determined price ("strike") by a specific date ("expiry"). An "outright" is another name for a single option leg. A "spread" is when options are bought at one strike and an equal amount of options are sold at a different strike, all at the same expiry.

Spot Rate: Reflects real-time market supply and demand for an asset available for immediate delivery.

SEC 30-Day Yield: The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.

Swaption: A contract to purchase the right to enter into a swap contract during the specified period of time.
